### **IMPORTANT DAYS**

#### 29th August 2024 National Sports Day

- To honor Major Dhyan Chand, a legendary hockey player. Major Dhyan Chand, known as "The Wizard of Hockey" was born on August 29, 1905 in Uttar Pradesh.
- Prime Minister Narendra Modi launched the "Fit India Movement" on National Sports Day in 2019.



The National Sports Day is also an occasion that sees the nation honour its sporting heroes with recognitions like the Major Dhyan Chand Khel Ratna (formerly called the Rajiv Gandhi Khel Ratna), Arjuna Award, Dhyan Chand Award and the Dronacharya Award.



#### 29th August - International Day Against Nuclear Tests

- In 2009, the 64<sup>th</sup> session of the United Nations General Assembly declared 29<sup>th</sup> August the International Day against Nuclear Tests.
- The resolution was initiated by the Republic of Kazakhstan and it was first observed in 2010.

### **APPOINTMENTS**

Senior IPS officer B Srinivasan was appointed as the Director General (DG) of the National Security Guard (NSG)

- B Srinivasan will replace Anish Dayal Singh (CRPF Director General), who was given the additional charge of the DG of National Security Guard (NSG) till August 31, 2027.
- Then NSG Director General Nalin Prabhat was appointment as a special DGP of the Jammu and Kashmir Police.





#### Satish Kumar named new Chairman and CEO of Railway Board

- Mr. Kumar will replace Jaya Verma Sinha, is the first lady Chairperson of the Railway Board, will retire on August 31.
- Mr. Kumar will assume charge from September 1, till the date of his super annuation and his re-employment on contract basis, from January 1 till August 31, 2025.

## **SCHEME & INITIATIVE**

#### Himachal Government Approves 'Mukhya Mantri Sukh Shiksha Yojana'

The scheme aims to provide financial support to identified **socially** and **economically vulnerable women** and **parents of disabled children** so as to enable the education and well -being of their children.

#### Eligibility

Widows, destitute women, divorced women with children
Parents of disabled children.



The income of the eligible women and parents of disabled children shall not be more than Rs.
1 lakh per year.

#### **Benefits**

- Parents of children under 18 years will receive monthly financial assistance of Rs. 1000 per month from the state government to cover the child's educational, nutritional and health expenses.
- State government assistance will be provided to children pursuing undergraduate, postgraduate, diploma or vocational courses to meet tuition fees and hostel costs.
- The scheme aims to prevent issues such as child abuse, trafficking, teenage marriages and drug abuse by strengthening child protection at the family level.

#### Himachal Pradesh passes Bill to raise women's marriage age from 18 to 21 years



- The Himachal Pradesh State Assembly passed the Prohibition of Child Marriage (Himachal Pradesh Amendment) Bill, 2024 increasing the minimum age of marriage for women from 18 to 21 years in order to support gender equality and higher education.
- The Bill amended the Prohibition of Child Marriage (PCM) Act, which was passed by Parliament in 2006.

#### **REPORTS**

**'UP Digital Media Policy 2024': Rs. 8 lakh monthly income** for promoting policies, life imprisonment for anti-national content

- The 'UP Digital Media Policy 2024' was cleared by the UP cabinet.
- Under the policy, the government would give advertisements to eligible visual and digital media firms and influencers active on popular social media platforms of X, Facebook, Instagram and YouTube.
- The social media agencies would be segregated into four broad categories based on the count of subscribers and followers.
- The maximum payment to account holders, operators and influencers of X, Facebook and Instagram has been fixed at Rs. 5 lakh, Rs 4 lakh, Rs 3 lakh per month respectively.

UP's New Social Media Policy: Rs 8 lakh monthly income for promoting policies, life imprisonment for antinational content



- Category-wise ceiling for payment pertaining to videos, shorts and podcasts and other type of content on YouTube has been fixed at Rs. 8 lakh, Rs. 7 lakh, Rs 6. lakh and Rs. 4 lakh per month respectively.
- Meanwhile, for derogatory posts, police currently books the accused under Section 66 (E) and 66 (F) of the IT Act.
- Under the new policy, if found guilty, there is a provision for punishment ranging from three years to life imprisonment for creating anti-national, obscene or objectionable content.



'Goa To Pakistan To Goa': Christian Man's Journey To Becoming First Indian Citizen Under CAA In State

#### Pakistani Christian is first Goan to get Indian citizenship under CAA

- Soseph Francis A. Pereira, a Christian from Pakistan, has become the first person in Goa to receive Indian citizenship under the Citizenship Amendment Act (CAA).
- The Citizenship Amendment Act allows Hindus, Sikhs, Jains, Christians, Parsis and Buddhists from neighboring countries - Bangladesh, Pakistan and Afghanistan, who entered India before December 31, 2014 to apply for citizenship after verification.

#### AWARD & ACHIEVEMENT

#### PM Jan Dhan Yojna completes a decade; 53 crore beneficiaries so far

- The Pradhan Mantri Jan Dhan Yojana (PMJDY) completes 10 years of implementation. It launched by PM Modi ten years ago on August 28, 2014.
- It is a National Mission for Financial Inclusion to ensure access to financial services, namely, a basic savings & deposit accounts, remittance, credit, insurance, pension in an affordable manner.
- The government aims to open more than 3 crore accounts under PMJDY during the current financial year 2024-25.
- The JAM Trinity (Jan Dhan, Aadhaar, Mobile) has given a boost to the Direct Benefit Transfer programme and expanded its coverage from partial to ubiquitous.
- The Financial Inclusion Index (FI Index) stood at 64.2 in March 2024 from 60.1 in March 2023. Under the PMJDY, there are no account opening charges, no account maintenance charges, and no minimum balance charges.



Free RuPay debit card, with in-built accident insurance cover of Rs. 2 lakh and access to overdraft facility of up to Rs. 10,000 are other major features of the scheme.
